



MKH KAJANG INTERNATIONAL 12 HOUR WALK 2017

General Rules / Regulations

The event is to be held under the specific rules of the MKH Kajang International 12 Hour Walk Organising Committee set out herein. The MKH KAJANG INTERNATIONAL 12 HOUR WALK 2017 is hereafter being referred to as the "Walk Event".

1.0 **Organiser**

Persatuan Lumba Jalan Kaki Malaysia

1.01 **Supported by**

Ministry of Youth and Sports
Majlis Perbandaran Kajang (MPKj)

2.0 **Participation**

2.01 This walk is open to ALL with age above 18 years' old.

2.02 The Organising Committee reserves the right to reject any entry or entries received without giving any reason and any decision of rejection shall be final.

2.03 Entries are limited to 800 only and will be on first come first serve basis.

2.04 Participants must register in their individual categories to be eligible for the mixed team event.

3.0 **Venue/Course for the Walk Event**

3.01 Wisma MKH

3.02 Each lap/circuit of the course is 1,000 Meters

4.0 **Date & Time**

Starting Saturday November 11, 2017 2000 Hours

Ending Sunday November 12, 2017 0800 Hours

5.0 **Categories of participants Age (as at November 31, 2017)**

5.01 Men Open [12 Hour Walk + 50km] Above 18 years old

5.02 Men Senior Veteran [12 Hour Walk + 50km] Above 60 years old

5.03 Women Open [12 Hour Walk + 50km] Above 18 years old

5.04 Women Senior Veteran [12 Hour Walk + 50km] Above 60 years old

5.05 Mixed Team [4 members / at least 1 Female] Above 18 years old

6.0 **Conditions of Entry & Fees**

6.01 **RM100.00– before November 1, 2017 per competitor for each entry.**

6.02 Mix Team Category is **FREE Entry**, but participants must register as Individual Category to be eligible for it.

6.03 Participants are encourage to register Online at www.racexasia.com

6.04 Paper entry form can be downloaded from www.racewalkermalaysia.com

6.05 Qualifying age is 18 years and above as on 31 December, 2017.

6.06 No refund will be made once submitted or wrongly entries or multiple.

6.07 Substitution is NOT allowed.

7.00 **Health/Fitness of Competitors**

7.01 All competitors who take part in this walk must be medically fit to participate the whole duration of the 12 Hour Walk.

7.02 While every possible step is taken to ensure the safety of competitors, the Organising Committee will not be responsible for any accident, injuries or death however caused before, during or after the competition.

7.03 The Medical Doctor/Personal appointed by the Organising Committee will have the right to stop any competitor from further participating in the Walk Event if in the opinion of the Medical Doctor/Personal there is danger to the life or health of the competitor concerned.

8.00 **Determination of Winners**

8.01 All competitors must START at the START/FINISH LINE AT 2000 hours on November 11, 2017, failing to start the competitor/competitors is considered voluntarily withdrawing from the competition.

8.02 For the purpose of the determination of the winners, the Walk Event shall end at the START/FINISH LINE on the course.

8.03 Subject to any penalty or disqualification by the Judges, the competitor who has covered the longest distance shall be declared the winner.

8.04 The Walk Event shall be deemed to have been concluded at the end of the 12th hour after it has been commenced.

8.05 Competitors who cover a distance of 10km or more will be awarded an e-Certificate of Participation.

8.06 Medals will be given to participants who cover more than **40km for Men 30km for Women.**

8.07 Men / Women - 50KM Walk competition will be base on the result of Men / Women Open & Senior Veteran Event, for the first three walkers completing the 50KM Walk will be awarded the Cash Prizes.

8.08 Team winner will be determined base on overall total distance completed by four members in each team

9.00 Prizes

- 9.01 Cash Prizes will be awarded to winners for individual categories of the Walk Event as listed below. In order to be qualified for receiving these cash prizes, the competitors must cover **at least 50km** in the case of men categories & **40km** in the case for the women categories.
- 9.02 **1 (one) best Malaysian performer in MKH Kajang International 12 Hour Walk (Man or Woman) will be sponsored to take part in the coming Hong Kong 50km walking 2018 event. The prize includes return air-tickets (economy class) & accommodation (2D1N).**

10.0 Reporting Time

- 10.01 All competitors must collect their numbers at the venue on Saturday November 11, 2017 between 2.00 pm to 7.00 pm (no numbers and chips will be issued after deadline).
- 10.02 All competitors must report for briefing at 1930 Hours on November 11, 2017 at the designated point determined by the Organising Committee.
- 10.03 Any competitor who fails to report on time and/or does not have the "Timing chip" will not be allowed to Start and is considered to have been voluntarily withdrawn from the competition.

11.0 Leaving the Competition Venue/Arena

- 11.01 At all times during the competition, a competitor must remain within the premises of the "Competition Venue/Arena".
- 11.02 When a competitor leaves the competition arena without the permission, he or she is considered voluntarily withdrawing from the competition.

12.0 Numbers

- 12.01 Competitors shall wear only numbers provided by the Organising Committee.
- 12.02 The numbers must be pinned onto the clothing of the competitor, one number on the chest and another at the back.
- 12.03 No tampering with the competition numbers is allowed and any competitor doing so will be disqualified.
- 12.04 No transfer of competition number to another competitor or another person is allowed. Any such transfer will result in automatic disqualification.

13.0 Award of Winners

- 13.01 The winners shall be determined by the longest distances covered by the competitor.
- 13.02 Any walker who is found to have infringed the rules of competitive walking shall be penalized by having one lap deducted from the total distance covered by the competitor concerned. Thus, one infringement will mean a loss of one lap in distance covered by the competitor and subsequent infringements will mean a loss of one lap for each infringement.
- 13.03 The competitor who has committed an infringement will be shown one yellow card and the total distances to be deducted will therefore depend on the number of yellow cards accumulated by the competitor.
- 13.04 The decision of the Organising Committee is final and no appeal or correspondence will be entertained.

14.0 Solving a Tie

- 14.01 In the event of more than one competitor being adjudged to have finished the race with the same distances, the following rules shall apply.
- 14.02 A count-back with the competitor covering the most number of laps of the circuit during the last 9 hours of the race declared the winner.
- 14.03 If a tie still exists in the competitor who covers the most number of laps in the last 6 hours or the last hours, as the situation may warrants, be declared the winner.
- 14.04 If a tie still remains after the count back system as above, the competitor returning the best time (lowest time) in the most number of laps in the last 3 hours of the race will be declared the winner.

15.0 Conduct

- 15.01 Any competitor found guilty of misconduct will be disqualified.
- 15.02 Competitor must wear clothing which is clean and designed and worn as not to be objectionable. The clothing must be made of a material which is non-transparent even if wet.
- 15.03 Any jostling, obstruction or interpersonal act of aggression by one competitor against another aimed at impeding his/her progress shall be liable for disqualification.
- 15.04 Pacer is not allowed during the Walk Event. Any competitor found with a pacer will be liable for disqualification.
- 15.05 Participants are barred from wearing any attire displaying unethical messages.

16.0 Rest and food areas

- 16.01 Adequate refreshments will be provided by the Organising Committee for the duration of the Walk Event.
- 16.02 The rest and food areas are located with proper signs. Only competitors and officials are allowed to have access to these areas.
- 16.03 All Competitors are encouraged to prepare their own Refreshment/Food if they do desire, a special location will be provided
- 16.04 Any litter to be thrown must be at the refreshment station **designated BIN** only. Each littering will result in deduction of **ONE** lap.

17.0 Personal Belongings

- 17.01 Personal belongings of the competitors can be kept at the Baggage Area for **FREE** and a tag will be issued by the officer in charge of the Baggage Area. The tag must be produced when the competitor wishes to claim his/her personal belongings.
- 17.02 Competitors should only bring the bare essentials and no fragile or valuable belongings should be brought on to the circuit. The Organising Committee shall not be held responsible for any loss of any items which are placed at the Baggage Area or anywhere.
- 17.03 All personal belongings must be collected from the Baggage Area by 8.30am after the race has ended.

18.0 Finish of the Race

The race officially ends at 0800 hours on the November 12, 2017

19.0 Prize Presentation

- 19.01 All winners are required to wear official attire, provided by the organizers, for the prize presentation ceremony. Only shoes are allowed at the prize presentation ceremony
- 19.02 Prizes presentation will be held at 0830 hours on November 12, 2017.
- 19.03 Winners must be present for the prize presentation. No representatives are allowed. Failing to do so, prize money will be forfeited.
- 19.04 All photos and video recording taken before, during and after the Walk Event is property of the organizer and shall be used for current and future official walk promotions and merchandizing.
- 19.05 All prizes must be collected by 09.30 hours on November 12, 2017

20.0 Lucky Draw

- 20.01 The lucky draw is only open to MKH Kajang International 12 Hour Walk 2017 participants.
- 20.02 The draw will take place on November 12, 2017 (Sunday), 8.30am during prize presentation.
- 20.03 Each MKH Kajang International 12 Hour Walk 2017 participant is only entitled to 1 lucky draw chance.
- 20.04 The draw is based on participant's race bib number.
- 20.05 Winners must be present during the draw presentation to claim their prizes.
- 20.06 Otherwise, a re-draw will take place and the prize will be given to the subsequent winner of the draw.
- 20.07 Organiser's decision is final.

21.0 Closing Date

- 21.01 The online e-submission and paper submission Closing Date for the Walk Event shall be **November 1, 2017**
